

IMPORTANT SAFETY NOTICE

VOLUNTARY RECALL OF SYNCROS 2016 FL1.0 OFFSET SEATPOSTS WITH 27.2MM DIAMETER

Dear Partners

With this communication we have to inform you about a voluntary recall which concerns the Syncros 2016 FL1.0 Offset Seatposts with a 27.2mm diameter assembled on SCOTT 2016 Road bikes.

The recall affects the following road bike models:

In addition the following after-market seatpost of model year 2016 is affected as well, sold as a single part in bike shops

228381 Seatpost Syncros FL1.0 Carbon Offset 27.2mm

SCOTT road bike and mountain bike models that are not listed above are not affected by this recall.

SCOTT is conducting this recall as the seatposts from these bikes can fracture. Such fractures can lead to immediate loss of rider control over the bicycle and may cause accidents with severe injuries.

Therefore SCOTT requests costumers to

A) immediately stop using the concerned bikes and

B) take their bike to an official SCOTT dealer in order to have the seatpost replaced.

If a recalled road bike is being returned to your store you are requested to replace the seatpost. After the replacement of the seatpost the bike is safe to be used again. New seatposts can be ordered under www.customerportal.scott-sports.com.

If you have any of the affected road bikes in your in inventory you are not allowed to use or sell these bikes unless you have proceeded as instructed above.

SCOTT will provide the new seatposts free of charge.

Please note that you are obliged to destroy recalled seatposts that are returned to your store. You are therefore requested to cut off the head of the recalled seatpost and send it to a SCOTT facility with a pre-paid envelope that is enclosed to each replacement seatpost shipment.
